An Ordinance of the City of Key West, Florida, amending Chapter 18 of the Code of Ordinances, entitled " Businesses" by creating Article XIV titled "Fitness Centers", Division I, entitled "Automated External Defibrillators"; Creating Sec 18-710 titled "Definitions"; Creating Section 18-711 entitled "Regulations"; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date.
